## DERIVATIVES

A total of six contracts worth Kes.487,000 was traded in today's trading session. One NSE 25 contract expiring in 19<sup>th</sup> September 2019 worth Kes.352,000 was concluded at a price of Kes.3525.00. This is against an end of day price of Kes.3442.00 posted in the spot market.

## EQUITIES

Market turnover rose to Kes.585M from the previous session's Kes.382M, the number of shares traded stood at 13.7M against 14M posted yesterday.

## INDICES

The NSE 20 share Index was 12.58 points higher to stand at 2457.70.  
All Share Index NASI shed 4.81 points or 3.27% to stand at 142.19.  
The NSE 25 Share index shaved-off 64.82 points to settle at 3442.01.

## Banking

The Banking Sector had shares worth Kes.166M transacted which accounted for 28.32% of the day's traded value. Equity Group Holdings actively moved 2.1M shares valued at Kes.85M at between Kes.39.05 and Kes.39.65. KCB Group unchanged at Kes.39.95 moved 1.4M shares valued at Kes.58.8M. I&M Holdings moved 305,000 shares worth Kes.14.3M and closed at Kes.46.75.

## Energy & Petroleum

The Energy & Petroleum sector had shares worth 5.3M traded which accounted for 0.91% of the day's traded value. KenGen moved 936,000 shares valued at Kes.5M at between Kes.5.50 and Kes.6.00.

## Manufacturing & Allied

The Manufacturing and Allied sector had shares worth 261M traded & accounted for 44.57% of the day's traded value. E.A Breweries was the day's main feature with 1.3M shares valued at Kes.258M changing hands at between Kes.193.00 and Kes.195.25.

## Telecommunication

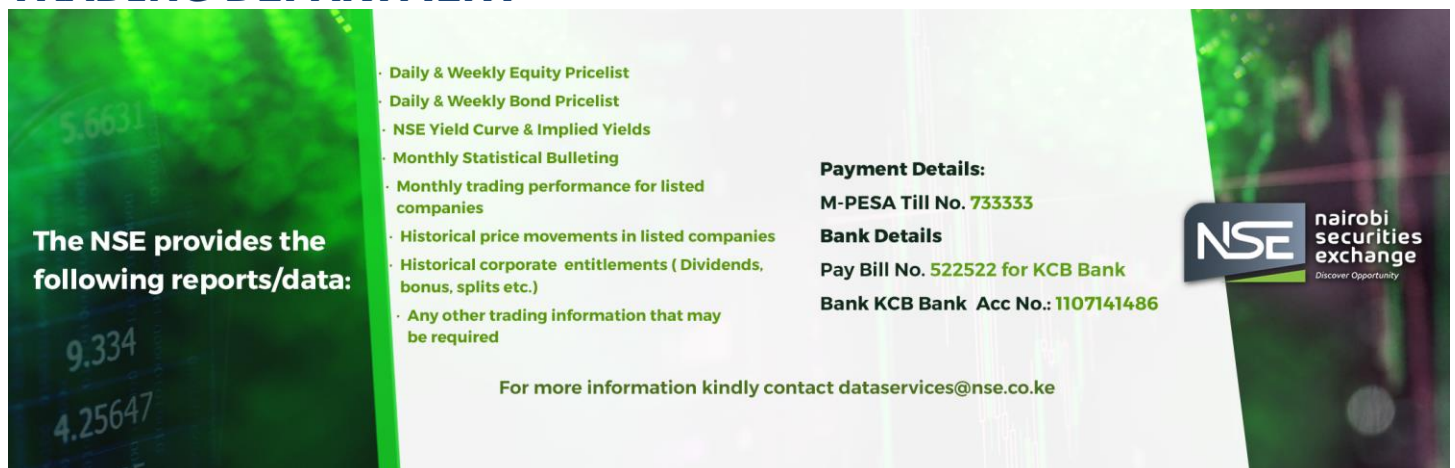
