DERIVATIVES

In the Derivatives Market, the Safaricom contract expiring in 19th December 2019 moved 1 contract valued at Kes.29,000.

EOUITIES

In the spot Market, the bourse opened the week with a total of 8.8M shares valued at Kes.279M, against 14.6M shares valued at Kes.337M posted on Friday.

INDICES

The NSE 20 share Index was up 0.90points to stand at 2653.85.

All Share Index NASI shed 0.50 points to stand at 155.48.

The NSE 25 Share index was down 3.04 points to settle at 3849.02.

Banking

The Banking Sector had shares worth Kes.115M transacted which accounted for 41.32% of the day's traded value. Equity Group Holdings moved 1.5M shares valued at Kes.74.7M at between Kes.47.20 and Kes.48.25. KCB Group unchanged at Kes.50.25 moved 585,000 shares worth Kes.29M. Co-operative Bank moved 343,000 shares valued at Kes.5M and closed at Kes.15.10.

Energy & Petrolum

The Energy & Petroleum sector had shares worth 2.3M traded & accounted for 0.85% of the day's traded value. KenGen traded 296,000 shares valued at Kes.1.7M at between Kes.6.00 and Kes.6.10.

Manufacturing & Allied

The Manufacturing & Allied sector had shares worth 37M traded & accounted for 13.26% of the day's traded value. E.A Breweries moved 183,000 shares valued at Kes.36.9M at a fairly stable price of Kes.201.00.

Telecommunication

Safaricom was the day's biggest mover with 4M shares valued at Kes.116.9M changing hands at between Kes.28.40 and Kes.29.95; this represented 41.85% of the day's traded value.
