## **EQUITIES**

Market turnover rose to Kes.587M from the previous session's Kes.102M, the number of shares traded stood at 14M against 7.7M posted yesterday.

## **INDICES**

The NSE 20 share Index was 4.19 points higher to stand at 2483.17.

All Share Index NASI shed 0.06 points to stand at 148.13.

The NSE 25 Share index added 12.26 points to settle at 3541.41.

## **Banking**

The Banking Sector had shares worth Kes.202M transacted which accounted for 34.42% of the day's traded value. Equity Group Holdings actively moved 4M shares valued at Kes.166M at between Kes.39.40 and Kes.40.50. KCB Group up fifteen cents to Kes.40.20 moved 461,000 shares valued at Kes.18.5M. Barclays Bank moved 994,000 shares worth Kes.10.8M and closed at Kes.10.90.

## **Energy & Petroleum**

The Energy & Petroleum sector had shares worth 7.3M traded which accounted for 1.25% of the day's traded value. KenGen moved 1.2M shares valued at Kes.6.9M at between Kes.5.50 and Kes.5.70.

## **Investment**

The Investment sector had shares worth 24.7M traded & accounted for 4.22% of the day's traded value. Centum closed the day 1.10% lower to Kes.31.25 moving 791,000 shares valued at Kes.24.7M.

## **Manufacturing & Allied**

The Manufacturing and Allied sector had shares worth 211M traded & accounted for 35.94% of the day's traded value. E.A Breweries was the day's main feature with 961,000 shares valued at Kes.192M changing hands at between Kes.195.25 and Kes.200.00. B.A.T moved 36,000 shares valued at Kes.18.7M and closed at Kes.511.00.

## **Telecommunication**

Safaricom had 4.9M shares valued at Kes.138M transacted at between Kes.28.05 and Kes.28.30; this represented 23.65% of the day's traded value.
