DERIVATIVES

The Derivatives Market had a total of 10 contracts valued at Kes.310,000 transacted in today's trading session. The Safaricom contract expiring in December 19, 2019 moved 6 contracts worth Kes.180,000 at a fairly stable price of Kes.30.10.

EQUITIES

Boosted by the sale of Safaricom and Equity Group Holdings shares, turnover soared to Kes.1.1Bn from the previous session's Kes.464M, the number of shares traded stood at 27.1M against 14M posted yesterday.

INDICES

The market indicators registered mixed results as follows;
The NSE 20 share Index was down 8.61 points to stand at 2600.17.
All Share Index NASI picked up 0.16 points to stand at 160.15.
The NSE 25 Share index was up 1.77 points to settle at 3940.20.

Banking

The Banking Sector had shares worth Kes.464M transacted which accounted for 41.31% of the day's traded value. Equity Group Holdings actively moved 7M shares valued at Kes.366.5M at between Kes.51.25 and Kes.52.25. KCB Group down twenty-five cents to Kes.50.75 moved 1.38M shares valued at Kes.70M. I&M Holdings moved 232,000 shares worth Kes.11.6M and closed at Kes.50.00.

Investment

The Investment sector had shares worth 31.7M traded & accounted for 2.83% of the day's traded value. Centum moved 1M shares valued at Kes.31.7M at a fairly stable price of Kes.30.50.

Manufacturing & Allied

The Manufacturing & Allied sector had shares worth 167.9M traded & accounted for 14.95% of the day's traded value. E.A Breweries moved 868,000 shares valued at Kes.167M at between Kes.192.25 and Kes.196.00.

Telecommunication

Safaricom was the day's biggest mover with 15M shares valued at Kes.454M changing hands at between Kes.29.80 and Kes.30.25; this represented 40.47% of the day's traded value.
