## EQUITIES

Market turnover rose to Kes.747M from the previous session's Kes.511M, the number of shares traded stood at 45.5M against 10.7M posted yesterday.

## INDICES

The NSE 20 share Index was up 9.79 to stand at 2437.15.

All Share Index NASI picked up 043 points to stand at 143.47.

The NSE 25 Share index edged up 11.93 points to settle at 3433.88.

## Banking

The Banking Sector had shares worth Kes.342M transacted which accounted for 45.84% of the day's traded value. Barclays Bank actively moved 23M shares valued at Kes.251M at between Kes.10.80 and Kes.11.00. Co-operative Bank up 3.18% to Kes.11.35 moved 6.4M shares valued at Kes.73M. I&M moved 218,000 shares worth Kes.9.8M and closed at Kes.45.00.

## Energy & Petroleum

The Energy & Petroleum sector had shares worth 2.2M traded which accounted for 0.30% of the day's traded value. KenGen exchanged 274,000 shares valued at Kes.1.5M at between Kes.5.50 and Kes.5.54.

## Manufacturing & Allied

The Manufacturing and Allied sector had shares worth 12.4M traded & accounted for 1.66% of the day's traded value. E.A Breweries moved 62,000 shares valued at Kes.12M at a fairly stable price of Kes.197.75.

## Telecommunication

Safaricom was the day's main feature with 14M shares valued at Kes.385M at between Kes.26.95 and Kes.27.40; this represented 51.58% of the day's traded value.
