EQUITIES

Boosted by the sale of Equity Group Holdings shares, turnover rose to Kes.1.98Bn on 51M shares against 11.6M shares valued at Kes.361M posted yesterday.

INDICES

The NSE 20 share Index was up 20.60 points to stand at 2456.34.
All Share Index NASI picked up 2.18 points to stand at 148.28.
The NSE 25 Share index was up 52.50 points to settle at 3526.37.

Banking

The Banking Sector had shares worth Kes.1.7Bn transacted which accounted for 88.80% of the day's traded value. Equity Group Holdings was the day's main feature with 40.9M shares valued at Kes.1.5Bn changing hands at between Kes.37.15 and Kes.38.50. Diamond Trust Bank closed the day 1.77% higher to Kes.115.00 moving 1M shares valued at Kes.123.7M. KCB Group recorded a 3.99% gain to close the day at Kes.42.60 with shares worth Kes.68.6M transacted.

Construction & Allied

The Construction & Allied sector had shares worth 14M traded & accounted for 0.71% of the day's traded value. Bamburi Cement down 4.62% to Kes.93.00 moved 150,000 shares valued at Kes.14m.

Manufacturing & Allied

The Manufacturing & Allied sector had shares worth 59M traded & accounted for 2.99% of the day's traded value. E.A Breweries moved 306,000 shares valued at Kes.59M at between Kes.191.00 and Kes.193.00.

Telecommunication

Safaricom had 5.1M shares valued at Kes.145M transacted at between Kes.27.85 and Kes.28.50; this represented 7.33% of the day's traded value.
