EQUITIES

Market turnover retreated to Kes.332M from the previous session's Kes.653M, the number of shares traded stood at 19M against 11.6M posted yesterday.

INDICES

All NSE indices registered positive gains as follows;
The NSE 20 share Index was up 0.28 points to stand at 2431.64.
All Share Index NASI picked up 0.42 points to stand at 144.30.
The NSE 25 Share index added 12.57 points to settle at 3458.34.

Banking

The Banking Sector had shares worth Kes.263M transacted which accounted for 79.20% of the day's traded value. Equity Group Holdings was the day's main feature with 3M shares valued at Kes.114M changing hands at between Kes.37.60 and Kes.39.00. KCB Group edged up 0.64% to Kes.39.15 with shares worth Kes.70M transacted. Co-operative Bank moved 5.2M shares worth Kes.63M and closed at Kes.12.10.

Energy & Petroleum

The Energy & Petroleum sector had shares worth 32.7M traded which accounted for 9.85% of the day's traded value. KenGen moved 5.7M shares valued at Kes.31.8M at between Kes.5.54 and Kes.6.00.

Insurance

The Insurance sector had shares worth 3.6M traded & accounted for 1.09% of the day's traded value. Kenya-Re had 1.1M shares valued at Kes.3.3M transacted at between Kes.2.90 and Kes.2.99.

Telecommunication


Safaricom exchanged 1M shares valued at Kes.29M at between Kes.27.15 and Kes.27.50; this represented 8.84% of the day's traded value.
