The Banking Sector had shares worth Kes.248M transacted which accounted for 56.60% of the day's traded value. ABSA Bank Kenya was the day's mover with 11M shares valued at Kes.115M traded at between Kes.10.50 and Kes.10.80. Equity Group Holdings shed 6.13% to Kes.33.70, with shares worth Kes.56.3M transacted. KCB Group moved 1M shares worth Kes.36.2M and closed the day at Kes.35.90.

### Commercial & Services

The Commercial & services sector had shares worth 1.6M traded & accounted for 0.38% of the day's traded value. Kenya Airways moved 473,000 shares valued at Kes.865, 000 at a relatively stable price of Kes.1.83. Nation Media Group had shares worth Kes.409, 000 and closed the day at Kes.18.50

### Manufacturing & Allied

The Manufacturing & Allied sector had shares worth 56M traded & accounted for 12.82% of the day's traded value. B.A.T remained stable at Kes.315.00 moving 165,000 shares valued at Kes.52M. E.A Breweries registered shares worth Kes.4.1M in today's trading session and closed at Kes.165.00.

### Telecommunication

Safaricom actively moved 4.7M shares valued at Kes.128M changing hands at between Kes.26.90 and Kes.28.00; this represented 29.29% of the day's traded value.
